Annual Meeting Highlights

The annual meeting was held June 9, 2007. Board members present were Phil Meenach, Jack Bielinski, Doug Shorb, Scott Seely, Don Brewer and June Cade. Absent was Jack Kling, Jim May and Ron Dicklin.

Board members were introduced and candidates listed on the ballot each spoke briefly. No additional candidates were nominated from the floor.

The proposed change to the bylaws regarding the date for annual meetings was explained. Because our highest expenses occur between June and September, holding the meeting closer to the end of the fiscal year (Sept. 30) will allow for a more accurate proposed budget. Another benefit of a later meeting date will make it easier to avoid heavy holiday weekends, June weddings and graduations.

The status of the Water Project was reported. The assessment proposed to complete the project is \$150 per lot.

FINANCIAL: Annual dues are proposed to remain the same as last year's—\$400 per lot. Following a discussion regarding the proposed budget, it was moved and seconded to approve the dues and budget as presented. Except for one dissenting vote, the show of hands was unanimous.

PARK & POOL: Electrical work required to install the new security cameras is scheduled for completion within the next few weeks. Pavilion remodeling is under way with new wiring for lights and fans completed. Bathhouse painting is progressing and near completion. The pump powering the sprinklers at the park needed repair or replacement. Sprinklers are now activated.

WATER: Well automation is in progress. Monitoring and adjusting well activity will be possible through remote access.

According to reports of water usage, conservation remains necessary. (Recommended irrigation schedule and other conservation practices may be found elsewhere in this newsletter.) Questions arose regarding the accuracy of the reports and whether there may be undetected leaks in the lines. Volunteers will acquire detection equipment and test the mains, hydrants and houses for previously undetected leaks.

PLANNED DEVELOPMENT/PUD: Ron Dicklin, committee chairman, was absent so there was no discussion relating to the Planned Development master plan.

POOL & PARK: The playground equipment has been inspected by our insurance agent and pronounced safe.

The bathhouse has been repainted inside and ventilating fans repaired. The pavilion has a new ceiling, sink and countertop.

The next board meeting will be held **July 21**, 9:00 a.m. at the old office next to the fire hall. All members are encouraged to attend.

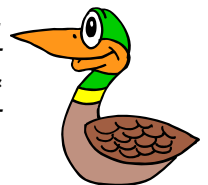

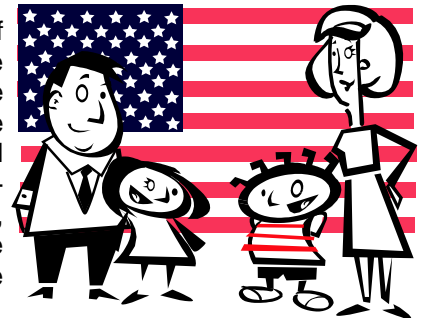
